OLD BUSINESS (PUBLIC SPEAKS): None

PUBLIC SPEAKS (CITY BUSINESS): Joseph Fisher received a letter from the Mayor's office stating that the investigation of May 29th is under investigation. He's questioning why it's taking so long and what information will be included in the investigation. Skylark Bruce took time to remember the deaths of Ace Lucas, Brandon Bush and Ronald Pleasant. She said that at the meeting on July 13 with Council Members and constituents, Council Members wouldn't make any statement for or against any proposed changes and placed the responsibility on the Administration. She believes there should be justice for the families of Ja"Ron Nero, Darryl Ross and Shawn Pirolozzi. Briana Grillon was in a car accident in 2018 in which her child died. She stated that the lead crash scene investigator for the CPD didn't come from a place of humanity, but instead was very insensitive towards her. She also felt that the Canton EMT and Mercy Medical personnel were very callus, judgmental and cruel and that the perpetrator was treated like a God. She said her family didn't receive the basic level of care from any of the first responders. Curstynn Marks wants to know why Council Members aren't individually supporting the 8 Can't Wait campaign. She wants Council to put pressure on the Administration to make the changes. She believes that crime exists because of food insecurities, homelessness, poverty and lack of resources and that funding should be put into community programs to prevent more violence. Ashley Green believes there needs to be more things for children and young adults to do, in a safe space, instead of spending money on the Hall of Fame and tourism. Melanie Welsh read the definition of "qualified immunity" and gave a copy to Council. She will return at the next meeting and get their opinion on it. She said it's time to start holding cops accountable and believes that police should have to carry their own personal liability insurance. If they did so, they'd be more careful. Sierra Mason recognized the families that lost members in the last week. She has an issue with so much money going into tourism and thinks it should be used to get our youth and our people invested in something directing them towards college, owning a business or something other than violence. She says the people are at war because they don't trust the system due to repeated brutality. She wants more access to information with resources after you've experienced some type of trauma such as community outreach, activities or educational programs. Brenden Perez, a pro black protester and blogger, attended a meeting where there was an open dialogue about the current events. The main issues were that there is no trust in the police to handle problems instead of escalating them and there is no accountability for police. He asked "What do you say to people who don't trust the police?" Jasper Robinson thinks it's a slap in the face to citizens to invest more money in the Police Department and Detective Bureau when they're the ones who provoked the events that occurred on May 29th by spraying the citizens with tear gas. He wants to know why the officers are being allowed to step down instead of being fired. Jennifer Robinson wants to know why it's taking so long to meet the requirements of the 8 Can't Wait. She said it took ½ hour for the responders to arrive at the shootings this week and wanted to know what the protocols are. She also stated that the reports they received regarding officers with disciplinary issues had the officer's names blackened out. She asked why Officer Vincent Roman is still on the police force and asked for other documents which do not have the officer's names blackened out.
