MISCELLANEOUS BUSINESS: Member Hawk voiced his concerns that people have begun putting gravel down on the devil strips in front of their homes and using that space for parking, causing constituents to have to walk in the street. Member Smuckler commented on Governor DeWine's opening the state on May 1 and wanted to know if City Hall will also re-open on that day and what actions will be taken to enforce the wearing of masks. Mayor Bernabei said that he is in talks with our Judges and the Law Department to determine what steps will be taken to open on or about May 4. He also stated that we still have a long way to go to work our way out of this situation. The challenges will be in the ramping up of testing, tracking and quarantining individuals. There still needs to be some clarification on face masks being "ordered" by the Governor; however, he does encourage everyone to wear them when going out in public. Mayor Bernabei also commented on a letter he sent to Council regarding the city's revenues. Member Scaglione thanked all first responders and those on the front lines during this pandemic, and included those who are not hospital or government workers.
