The Department of Community Development, on behalf of the City of Canton, is requesting proposals for the 2024 HOME grant program (HOME), 2024 Community Development Block Grant program (CDBG), 2024 Emergency Solutions Grant program (ESG), and for the HOME-ARP Grant program.

CDBG, HOME and HOME-ARP workshop: **Wednesday, November 15, 2023**
ESG workshop: **Thursday, November 16, 2023**
Application Period Ends – **Thursday, November 30, 2023**
Program Year begins - **July 1, 2024** pending the allocation of federal funds.

- **HOME ARP applications will be available online at [HOME-ARP | Canton, OH \(cantonohio.gov\)](https://www.cantonohio.gov/home-arp).** Email a letter of intent to apply to communitydevelopment@cantonohio.gov . **A reply email will be sent with instructions on uploading the application and required documents.** The email of intent to apply for HOME ARP funding must be submitted prior to the deadline of November 15, 2023.
