benefit of the Obligee named herein.

This bond is effective on and as of _____, 20____ and shall terminate upon the occurrence of any of the
following:

1. Upon the order or direction of the City of Canton, Ohio;
2. Upon surety delivering thirty (30) days' written notice to the City of Canton of its desire to terminate this bond. Such
cancellation or termination shall not affect any liability incurred or accrued thereunder prior to termination or
cancellation of said bond by said City of Canton, Ohio, or prior to the termination of the thirty (30) day period for notice,
if terminated by the surety;
3. On the 31st day of December of each year.
